We do not think this type of tiny project is multiyear project and DoNIDCR has not obtained Multi Year Project Approval for above contracts from National Planning Commission. Our concern is: If we supply goods in Fiscal Year 2079/2080 in above contract, will DoNIDCR will make payment to the above contract on time? If DoNIDCR does not make payment on time due to unavailability of budget or whatsoever reason, our investment will be at greater risk.
