Bids shall be opened in presence of Bidders' representatives who choose to attend on 13 Hrs. on 04/13/2021 at the office of Department of National ID and Civil Registration Singh Durbar, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 1,40,000.00 which shall be valid for minimum 30 days beyond the bid validity period.
