Bidding is open to all eligible Bidders.

5. Pre-bid meeting shall be held at Department of National ID and Civil Registration Singh Durbar, Kathmandu at 13 Hrs. on 2078-04-18 (2 August, 2021).
6. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Department of National ID and Civil Registration Singh Durbar, Kathmandu on or before 12 Hours on 2078-04-31 (15 August 2021).
7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14 Hrs. on 2078-04-31 (15 August 2021) at the office of Department of National ID and Civil Registration Singh Durbar, Kathmandu. Bids must be valid for a period of 90 days (Karitk 26, 2078) counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs.19,62,000.00, which shall be valid for minimum 30 days beyond the bid validity period (Magsir 26, 2078).
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. The Department of National ID and Civil Registration (DoNIDCR) reserves the right to reject, amend, partly or wholly or cancel the bids without assigning any reasons whatsoever.
